Club Rince Tuition and Policies

Tuition: Tuition is non-refundable and non-transferable for any reason. NO REFUNDS. All tuition is billed annually regardless of payment plans offered by Club Rince. Club Rince is a 10-month program with a 10-month commitment. Should you choose to leave before June 2023, all remaining tuition will be automatically charged to your credit card on file.

Monthly tuition:

- must be paid with a credit card through auto-pay portal and will incur a 3% fee. All tuition paid with credit card will incur a 3% fee.
- 1st & last month's tuition collected at time of enrollment.
- 10-month commitment. No refunds. Remaining tuition collected via credit card if dancer choses to leave Club Rince at any time for any reason.

Semester Tuition:

- 2 equal payments in September and January.
- All tuition paid with credit card will incur a 3% fee.
- A credit card is required to be on file in the portal and kept up to date regardless of payment method.
- 10-month commitment. No refunds. Remaining tuition collected via credit card if dancer choses to leave Club Rince at any time for any reason.

Make Up Classes: Dancers may make up missed classes at any point during same season in a comparable class at teacher's recommendation.

Class Cancelations: Club Rince reserves the right to cancel classes due to weather or any other reason with reasonable notice. Canceled classes will not be made up with additional classes unless excessive weather cancelation has occurred in a season. Dancers may make up their classes missed in any suitable class with written notice. Classes may not be made up in more advanced classes or troupe classes.

COVID-19: Club Rince reserves the right to go virtual or close at any time for any reason. We are unable to control government-mandated shutdowns or teacher sickness. Club Rince will adhere to all government and CDC mandates and recommendations regarding masking, distancing, and capacity limits. This may affect our schedule and require us to provide virtual classes.

Wardrobe & Performance: All youth dancers will incur a wardrobe fee for the 2022-23 dance year. Club Rince is a performance-based school and all dancers enrolled are expected to participate in all shows. This fee is non-refundable

regardless of changed participation in any performance or event. This fee covers contribution to the ever-growing wardrobe owned and managed by Club Rince. All items distributed must be returned in the same condition and in a timely manner. Accounts will be charged additionally for anything lost including items left behind at performances and events.

Dress Code: Any 'Club Rince' t-shirt or a white, blue, or black t-shirt or tank top. No other tops should be worn to class. This includes leotards, spaghetti strap tops, crop tops, tops with any sayings, logos, or designs other than Club Rince. Dancers are to wear black athletic shorts or skirts with shorts under. Leggings and tights are permitted in the cooler months. Jeans, jeggings, baggy sweatpants, etc. are not permitted in class. Only dance shoes are permitted on the dance floor. No outside shoes or socks only. Dancers may wear Irish soft and hard shoes, and dance sneakers. Black ballet slippers are permitted for beginner level classes. Hair must be tied back away from the face. No large jewelry, or hoop earrings.

Dancers' Code of Conduct: Kindness and respect are expected from all, always. Club Rince has zero tolerance policy for bullying. We reserve the right to dismiss any dancer or family that does not comply with all rules and policies of Club Rince, or at any time creates an unsafe environment, or who otherwise, in our judgment, disrupts the harmony or reputation of Club Rince. All dancers will review and sign a commitment to our Code of Conduct at the start of the year.

General policies: Club Rince and its owners are not responsible for lost or stolen items at class or performances. Please leave all valuables at home. There is no gum, food, or drinks other than water allowed in class unless otherwise specified. Please eat before class. Cell phone use is limited to emergencies only. NO photos or videos may be taken in class without teacher's permission. Distribution or posting of photos or videos taken during class is strictly prohibited.
